## Warranties

The warranties offered on products sold by SFP Ltd vary according to the product. Please ask for more information when ordering. All warranties are subject to compliance with the manufacturer's standard operating and maintenance instructions. The one year warrantee on new extinguishers is changed to five years whilst maintained by SFP Ltd in accordance with BS 5306 pt3.

#### VAT

VAT is not included in quoted prices and will be charged at the current rate when invoiced.

## **Payment Terms**

Authorised credit accounts terms are strictly 30 days net from date of invoice. An official invoice will be sent once goods are delivered or service completed. If any sum payable is not paid when due, that sum will bear interest from the due date until such time as the payment is made in full (in cash or cleared funds). All credit accounts are subject to approval by Company Directors and SFP Ltd who also reserve the right to refuse credit accounts. All credit accounts may be submitted for third party verification and approval. None account customers payment must be paid at the time of order or service. All prices and payment are to be in UK £ Sterling. Any invoice queries must be made within 7 days of receipt to the above address.

#### **Return of Goods**

Goods that have been ordered in error by the customer may be subject to a 15% restocking charge. If the goods were a **special order** and are not a standard stocked item they will be subject to a 25% restocking charge if agreed by SFP Ltd that the goods may be returned. All goods returned must be in the original packaging and in good order suitable for resale. All refunds will be by a credit to your account within 30 days of return. Delivered goods must be inspected and any claim for damage or deficiency made within 7 days.
